The easy way to rewrite the future – and help prevent cancer for generations to come.

Getting started...

Your will is your opportunity to control the future of your money and your possessions. In this way, you can make sure they are passed on in the way that YOU want. The information and worksheets below will help you plan out your wishes.

Before meeting with your solicitor or professional will writer you should:

Make a list of everything you own.

Please find enclosed a checklist to help you do this.

Choose who you want to include in your will.

Gifts can be anything you own, cash amounts or a percentage of your estate.

Have any essential information to hand.

This may include details of any property or land, life insurance, shares, pension details, bank or building society accounts and passwords for any electronic assets you have like Paypal, iTunes or online banking.

Think about Inheritance Tax.

Including a gift to charity in your will can be an effective way to reduce inheritance tax.

Please do take a little time to work through this guide. It will help you to gather your thoughts before meeting your will writer.

Decide who your executors, trustees and guardians should be.

Executors are people responsible for gathering assets and liabilities of your estate and distributing money from your will. Trustees are needed if your will creates a trust. Guardians are necessary for any children under 18. Of course, all of these should be people who you have complete faith and trust in.

Consider making residuary gifts to your chosen charities.

Residuary gifts (a % of your estate) are taken after pecuniary gifts (specific sums of money) have been made, so they're good to give to charities because they don't reduce the specific value of any pecuniary gifts you leave to family and friends.

You can prepare for writing your will by printing off and completing this simple checklist, or by making a note from this of all the things you need to consider before starting your will.

How to work out the value of your estate

Using this table you can make a list of everything you own and its approximate value. In the first section, you can work out the value of your assets (what you own); in the second section, your liabilities (what you owe). By deducting your liabilities from your assets, you can discover the value of your estate.
